## COMPLEX HEALTH CARE

The JPWC Community Health Centre is a full-service medical clinic, with a focus on complex health meaning that an individual seeking medical support from this clinic may have a combination of mental health issues, chronic conditions, medication-related problems and may be socially vulnerable.



## HOUSING & DEVELOPMENT

The JPWC owns, builds, and operates rental housing across Edmonton. Applicants must apply to live in JPWC developments, must be able to live independently, and must be able to pay rent. Our first development was built in 2011 in the area of Canora which has been nominated for Yards in Bloom for multiple years.



## EMPLOYMENT & COMMUNITY WEALTH

Our social purpose businesses focus on offering entry level employment and training to individuals who may be joining the work force for the first time, or have had trouble finding secure work for a multitude of different reasons. We believe in paying all staff a living wage, and creating opportunities for growth. Last year we put over 1M of payroll back into the community.



## FOOD LITERACY & ACCESS

Over the last 4 years, F4G has been working with vulnerable, and low-income families to increase their knowledge and skill level around preparing, cooking and growing good food. By operating comprehensive nutritional cooking classes for children, adults, and elders F4G has seen an increase in community members ability to prepare and cook healthy meals on a low-income budget, thereby improving their health outcomes and their ability to make better decisions. F4G also hosts monthly low-cost fruit and veggie markets that travel throughout our communities to provide access to good food at 30-50% below market prices.



## EDUCATION & COMMUNITY PROGRAMMING

We believe Education is the key to success in all areas of life. Education and community programming center around problem solving, resiliency, and skill development for vulnerable people. This programming is free and works on a drop-in basis, in an inclusive environment.

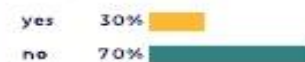
